

Privacy Notice (Vendor)

The **Data Controller** connected with this **Privacy Notice** is Nine Elms Real Estate Ltd trading as Battersea & Nine Elms Estates.

1. Purpose

In this instance your data is being processed for the specific purpose of selling your property.

2. Lawful Basis

The collection of your data for this purpose is under the Lawful Basis of Contract, because we require this information in order to fulfil our obligations under our contract to sell your property, as well as acting as your Agent expediting the contract between you and the buyer of your property.

3. Information Collected

The personal data we will collect and process about you in connection with this purpose is:

- 3.1. Name
- 3.2. Address (both for the property to be sold and for correspondence if they are different)
- 3.3. Telephone number(s)
- 3.4. Email Address
- 3.5. Proof of ID
- 3.6. Proof of Address
- 3.7. Company details if the property is owned by a company

In addition, we may collect other non-personal data regarding your property, for example, details regarding block management, service charges, ground rent, etc.

4. Retention

Under the Lawful Basis referenced in paragraph 2, your data will be retained to the end of the financial year in which your property sale is completed and for a further 6 years thereafter in accordance with HMRC requirements for financial record keeping. Thereafter some details of the property will be retained indefinitely for historical record keeping purposes, to aid any future evaluation of the property, past sales activity and property value.

5. Destruction

At the end of this retention period your data will be destroyed using an approved method unless prevented by Court order.

6. Data Sharing

Whilst we control your personal data we will need to share this data with the following parties, for the following purposes, in order to provide you with the services you are seeking from us:

- 6.1. Our IT support providers Computerate and Vebra (ZPG Ltd) for the sole purpose of providing Nine Elms Real Estate Ltd trading as Battersea & Nine Elms Estates with IT services to maintain and store a consumer database so we can provide you with our service.
- 6.2. Rightmove Group Ltd, ZPG Plc (Zoopla and Primelocation), property portals for the sole purpose of marketing the property.

- 6.3. Fulham Performance Ltd for the sole purpose of photography and floorplan production.
- 6.4. Contractors (various) for the sole purpose of cleaning or repairing a property prior to sale if necessary. Specific company details, if required, can be confirmed to the data subject when arrangements are made for such companies to visit your property.
- 6.5. The Buyer for the purpose of expediting the purchase.
- 6.6. The Buyer's and Vendor's solicitors for the sole purpose of facilitating the sale. The details of these firms will be made known to you in the Memorandum of Sale, which will be issued to all parties at the point at which the sale is agreed, subject to contract.
- 6.7. The other Agents in the "Chain" of sales / purchases associated with the sale, for the sole purpose of managing the sale.
- 6.8. The Buyer's Surveyor, for the sole purposes of arranging a survey of the property, should one be required and for the sole purpose of arranging access to the property.
- 1.1. The Property Ombudsman for the sole purpose of administering any investigation by them.
- 1.2. [The dispute service limited \(TDS\) for the sole purpose of using their Deposit Protection Scheme.](#)
- 1.3. [Adobe Inc for the sole purpose of sending legal documents or agreements.](#)

2. Rights of the Data Subject

3. Security

- 3.3. We do not generally hold personal data on paper. Where we do take it, we shred it just as soon as the details have been transferred onto our IT systems.
- 3.4. **Data Subjects** should be aware that not all electronic communications are secure. We use Transport Layer Security (TLS) to encrypt and protect email traffic in line with government advice. However, if your email service does not support TLS, you should be aware that any emails we send or receive may not be protected in transit.
- 3.5. We will also monitor any emails sent to us, including file attachments, for viruses or malicious software. Please be aware that you have a responsibility to ensure that any email you send is within the bounds of the law.
