

Privacy Notice (Employee Management)

The **Data Controller** connected with this **Privacy Notice** Battersea & Nine Elms Estates.

1. Purpose

In this instance your data is being processed for the specific purpose of managing your employment.

2. Lawful Basis

The collection of your data for this purpose is under the Lawful Basis of Contract because we require to process this data in order manage your contract of employment with Battersea & Nine Elms Estates.

3. Information Collected

The personal data we will collect and process about you in connection with this purpose is:

4. Retention

Under the Lawful Basis referenced in paragraph 2, your data will be retained until the date your employment ceases with the Company and then for a further 6 years thereafter, in accordance with CIPD advice.

5. Destruction

At the end of this retention period your data will be destroyed using an approved method unless prevented by Court order.

6. Data Sharing

Whilst we control your personal data we will need to share this data with the following parties, for the following purposes, in order to provide you with the services you are seeking from us:

- 6.1. Parties whose details have been given to Battersea & Nine Elms Estates by the data subject for referencing purposes.
- 6.2. Bespoke HR Ltd for the provision of Human Resourcing advice.
- 6.3. KBSP LLP for the provision of payroll services.
- 6.4. HSBC, the Company's bankers in order to pay your salary.
- 6.5. Nest Pensions, for the sole purpose of administering employee's pensions.

- 6.6. Computerate in conjunction with the IT support services they provide to Battersea & Nine Elms Estates, which enable to storage and processing of data.

7. Rights of the Data Subject

- 7.1. Under the UK General Data Protection Regulation, you, the Data Subject have certain rights regarding the control and processing of your personal data. Details regarding your rights can be found on the Information Commissioner's Office (ICO) [website](#).

8. Security

- 8.1. Recognising the importance of personal data to our employees, we endeavour to put in place appropriate organisational and technical measures to protect that data.
- 8.2. Personal data we hold on electronic media is encrypted and stored in a secure data centre located in the UK.
- 8.3. We do not generally hold personal data on paper. Where we do take it, we shred it just as soon as the details have been transferred onto our IT systems.
- 8.4. **Data Subjects** should be aware that not all electronic communications are secure. We use Transport Layer Security (TLS) to encrypt and protect email traffic in line with government advice. However, if your email service does not support TLS, you should be aware that any emails we send or receive may not be protected in transit.
- 8.5. We will also monitor any emails sent to us, including file attachments, for viruses or malicious software. Please be aware that you have a responsibility to ensure that any email you send is within the bounds of the law.

9. Data Protection Concerns
